BALI Code of Conduct

Members of the British Association of Landscape Industries must demonstrate their commitment to abide by the Association's Code of Conduct, as follows:

- To uphold the standing of BALI, its members, and the wider landscape industry by seeking to achieve and maintain the highest standards of business and professional expertise
- To provide services only within their areas of competence and be responsible for the actions of all their staff and sub-contractors
- To use appropriately trained staff and ensure on-going staff training and development
- To operate in an environmentally, ethically, and commercially sustainable manner
- To address client concerns promptly, maintaining professionalism and courtesy, and seek to negotiate an equitable solution in the case of a dispute
- To cooperate fully with the BALI dispute resolution service and quality standards review procedure (applicable to full vetted members only)
- To identify and meet customer, legislative and regulatory requirements

<p>FULL CONTRACTING</p> <p>A contracting business or an individual who has been trading more than 2 years and meets the membership criteria.</p>	<p>FULL CONTRACTING OVERSEAS</p> <p>As Full Contracting, but is resident and / or operating solely outside England, Scotland, Wales and Northern Ireland</p>
<p>FULL CONTRACTING GROUP</p> <p>A branch, section or division of a Full Contracting Member who has been trading more than 2 years.</p>	<p>REGISTERED DESIGNER</p> <p>Designers who have been trading for over 2 years, or a registered member of the Society of Garden Designers or hold current Chartered status of the Landscape Institute.</p>
<p>ASSOCIATE MEMBER</p> <p>A business or individual who has an interest in or involvement with the industry but is not eligible for full Membership. After 2 years of trading, you may apply for Full Contracting Membership.</p>	<p>ASSOCIATE DESIGNER</p> <p>A business or individual who is involved in landscape design but is not eligible for Registered Designer Membership. After 2 years of trading, you may apply for Registered Designer Membership.</p>
<p>AFFILIATE</p> <p>A company (section or division) or an individual that supplies material, equipment or a service to the landscape industry.</p>	<p>TRAINING PROVIDER</p> <p>A training provider involved in or with the landscape industry that is not eligible for any other category of membership.</p>
	<p>STUDENT</p> <p>An individual currently studying towards qualifications in landscape gardening, design or horticulture.</p>
